



## Beyond You Sweepstakes

### Official Rules

No purchase of any kind is necessary to enter or win. Making a purchase will not increase your chances of winning. Void where prohibited by law.

**ELIGIBILITY:** The Sweepstakes is open to AdvoCare Distributors and Preferred Customers who are legal residents of the United States and Canada, 18 years of age or older.

**HOW TO ENTER:** During regular ticket sales between October 16, 2019 at 10:00 am CT and January 23, 2020 at 11:59 pm CT, when you purchase a Beyond You ticket you will be entered for a chance to win a door prize at the event January 24-25, 2020. For alternative means of entry, mail in a 3 by 5 in. notecard with Sweepstakes name, full name, address, phone number, and Distributor/Preferred Customer ID to AdvoCare's address by January 16, 2019 at 5:00 pm CT. Only complete alternative entries will be added to the Beyond You event drawings January 24-25, 2020. Limit one entry per individual.
