

July 2026 Reimbursement Day Sweepstakes – July 16-17, 2026

Incentive Official Rules

Winner Selection and Notification:

One (1) entry is permitted per email. The number of Alternative Method of Entry submissions an individual may submit is limited to the maximum number of eligible purchase entries submitted by any one individual during the Sweepstakes Period.
