



AdvoCare Loyalty Week PR Package Sweepstakes – September 2, 2026
Official Rules

NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Sweepstakes Period

The AdvoCare Loyalty Week PR Package Sweepstakes (the “Sweepstakes”) begins on September 2, 2026, at 8:00 a.m. CT and ends on September 2, 2026, at 11:59 p.m. CT (Sweepstakes Period).

2. How to Enter

During the Sweepstakes Period, eligible individuals may enter through either of the following methods.

A. Qualifying Purchase Entry

Eligible Distributors, Preferred Customers, Registered Retail Customers, or Guests who place an order during the Sweepstakes Period will receive one (1) entry into the Sweepstakes for each order. Orders submitted before or after the Sweepstakes Period will not be eligible.

B. Alternative Method of Entry – No Purchase Necessary

To enter without making a purchase, send an email to Contests@AdvoCare.com during the Sweepstakes Period. The subject line of the email must state:

“AdvoCare Loyalty Week PR Package Sweepstakes **Entry**”

The email must include the Entrant’s:

- Full name;
- Mailing address;
- Telephone number; and
- Email address.

Each valid email submission constitutes one (1) entry. Emails received before or after the Sweepstakes Period, or emails that do not contain all required information, will not be eligible.

C. Entry Limit

Limit one entry per person during the Sweepstakes Period, regardless of method of entry.

Entries submitted through the Alternative Method of Entry are subject to the same overall entry limit as entries received through qualifying purchases. A purchase is not required to receive the maximum number of permitted entries.

3. Eligibility

The Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry. Void where prohibited or restricted by law.

Employees, officers, and directors of AdvoCare International, LLC ("**Sponsor**"), individuals or entities directly involved in the development, administration, advertising, or fulfillment of the Sweepstakes, and members of their immediate families or households are not eligible to enter or win.

For purposes of these Official Rules, "immediate family" includes a spouse, parent, child, sibling, and the respective spouses of each, regardless of where they reside.

Participation in the Sweepstakes constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions regarding the Sweepstakes, which are final and binding in all matters related to the Sweepstakes.

Any attempt by an Entrant to obtain entries through multiple or different identities, email addresses, automated systems, agents, or any other method may result in disqualification of all entries associated with that Entrant.

Entries submitted by anyone other than the Entrant are void. The use of automated systems, bots, scripts, agencies, or other automated methods to enter is prohibited.

4. Prize

100 winner(s) will each receive one (1) **AdvoCare Loyalty Week PR Package** (each, a "Prize"). The approximate retail value ("ARV") of each Prize is **\$60**. Limit one (1) Prize per person during the Sweepstakes Period, regardless of method of entry.

Prizes are non-transferable and may not be assigned or exchanged. No cash alternative will be provided except at Sponsor's discretion.

If a Prize or any component of a Prize becomes unavailable for reasons beyond Sponsor's reasonable control, Sponsor reserves the right to substitute a prize of equal or greater value.

5. Winner Selection and Notification

On or about September 3, 2026, Sponsor will randomly select 100 potential Winner(s) from among all eligible entries received during the Sweepstakes Period, regardless of method of entry.

Potential Winners will be notified by email at the email address associated with the winning entry and must respond within 48 hours of notification.

If a potential Winner cannot be fails to respond; is determined to be ineligible; fails to comply with these Official Rules; declines the Prize; or fails to provide required documentation, the potential Winner may be disqualified, and Sponsor may select an alternate potential Winner by random drawing from the remaining eligible entries.

Odds of winning depend on the total number of eligible entries received.

Winning a Prize is contingent upon compliance with these Official Rules and fulfillment of all applicable requirements.

6. Taxes and Other Prize Conditions

Winners are solely responsible for all federal, state, and local taxes, and any other costs associated with acceptance or use of a Prize that are not expressly stated in these Official Rules.

Sponsor may require a Winner to provide information reasonably necessary for tax reporting and will issue any tax forms required by applicable law.

Except where prohibited by law, acceptance of a Prize constitutes permission for Sponsor to use the Winner's name, likeness, photograph, voice, biographical information, and statements regarding the Sweepstakes for advertising and promotional purposes without additional compensation.

7. General Conditions

Sponsor's computer is the official timekeeping device.

Sponsor reserves the right, in its reasonable discretion, to disqualify any Entrant who: violates these Official Rules; attempts to tamper with the entry process or operation of the Sweepstakes; attempts to obtain more than the permitted number of entries; uses fraudulent, deceptive, abusive, or disruptive methods in connection with the Sweepstakes; or acts in a manner the Sponsor reasonably determines may compromise the fairness, integrity, security, or proper administration of the Sweepstakes.

If fraud, technical failures, unauthorized intervention, tampering, or any other circumstance beyond Sponsor's reasonable control materially impairs the integrity or proper administration of the Sweepstakes, Sponsor reserves the right to suspend, modify, or terminate the Sweepstakes and, if appropriate, select Winners from among the eligible entries received before the event requiring such action.

Sponsor is not responsible for lost, late, incomplete, inaccurate, misdirected, delayed, corrupted, or undeliverable entries, emails, communications, or notifications, whether caused by an Entrant, equipment, programming, human error, technical malfunction, network congestion, internet or email service failure, or otherwise.

Sponsor is not responsible for any technical malfunction or failure of any computer, server, network, hardware, software, telecommunications system, internet connection, email system, website, or other equipment used in connection with the Sweepstakes.

8. Release and Limitation of Liability

By participating in the Sweepstakes, Entrants agree, to the fullest extent permitted by law, to release and hold harmless Sponsor and its parent companies, subsidiaries, affiliates, officers, directors, employees, representatives, agents, advertising and promotion agencies, and prize suppliers (collectively, the "Released Parties") from and against claims, liabilities, losses, damages, injuries, costs, or expenses arising out of or relating to participation in the Sweepstakes or acceptance, possession, use, or misuse of any Prize.

Without limiting the foregoing, the Released Parties are not responsible for claims arising from: (a) unauthorized human intervention in the Sweepstakes; (b) technical or communications errors; (c) lost, late, misdirected, incomplete, or undeliverable entries or communications; (d) errors in the administration of the Sweepstakes or processing of entries; or (e) injury or damage to persons or property arising directly or indirectly from participation in the Sweepstakes or acceptance or use of a Prize.

To the extent permitted by applicable law, Entrants waive claims for punitive, consequential, incidental, indirect, or special damages arising from participation in the Sweepstakes.

For New Jersey residents, any limitations or waivers contained in these Official Rules are inapplicable to the extent attorneys' fees, court costs, damages, or other remedies are mandated by applicable statute.

By entering, Entrants acknowledge that they are providing their information to Sponsor and not to the applicable social media platform.

Entrants release the applicable social media platform from any responsibility or liability associated with the Sweepstakes to the extent permitted by applicable law.

10. Privacy

Sponsor will collect personal information from Entrants in connection with the administration of the Sweepstakes.

Information submitted in connection with the Sweepstakes will be used to administer the Sweepstakes, verify eligibility, contact potential Winners, fulfill Prizes, comply with applicable legal obligations, and for other purposes consistent with Sponsor's Privacy Policy.
